in the State aforesaid, in consideration of the sum of Seven Hundred DOLLARS, to me in hand paid at and before the sealing of these presents by W. P. Campbell

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

W. P. Campbell his heirs and assigns, All that lot of land situate in the State and County aforesaid, beginning at the northwest corner on a 16 foot street of the tract of land conveyed to me by H. P. McGee et al, and run thence S. 60.17 E. along said street 225 feet thence S. 22.53 W. 151 feet, thence N. 60.17 W. 225 feet, thence N. 22.53 E. 151 feet to the beginning corner, containing 74/100 acre, more or less, and being a part of the tract of land conveyed to me by H. P. McGee et al. the 6th day of March 1918, and recorded in Vol. 40 page 283.
