Clement agree to pay cash upon the signing of this contract \$250.00 as ernest money and upon the completion of the building \$4,750.00, or the first of Feb. 1920, or if completed before the 1st. of Feb. purchaser to pay a rental of \$150.00 per month or any portion thereof until the 1st, day of Feb. This, however, does not bind the Thos. M. Walker Co. to complete the building by the 1st. day of Feb.

It is understood between both parties that the buildings are to be completed as soon as possible. The remainder of the \$20,000 to be secured by notes and mortgages divided into payments as follows: \$5,000 - 2 yrs., 10,000- 5 years at 6% interest. Interest payable semi-ammually. The purchaser to carry fire insurance covering total value of building made payable to the holder of notes and mortgages. Is also to keep up all taxes, repairs, etc. on building. The said Thos. M. Walker Co. is to start immediately on the erection of the above named building and complete same as soon as possible. It is understood that this building is to be completed not later than the 1st, day of Feb. barring such delay over which the Thos.M. Walker Co., has no control.
