Taylor and Beulah Roper, on South by lot of J.R. Taylor and on West by C. & W.C. Railroad, shall be held and enjoyed in fee simple by the said W.T. Coleman, S.L. Coleman, Mary Thomason, Sallie Wham and D.A. Coleman in proportion to the following amounts, that is to say W.T. Coleman, S.L. Coleman, Mary Thomason and Sallie Wham, each twenty-two hundred nine and 50/100 Dollers, and D.A. Coleman, Eleven hundred sixty-one and 98/100 Dollars; and we, the legatees, devisees and executors of the said Robert Coleman, have granted, bargained, sold and released and do hereby grent, bargain, sell and release with the said W.T. Coleman, S.L. Coleman, - Vol. 61-Title to Real Estate.

Mary Thomason, Sallie Wham, and D.A. Coleman in the proportions aforesaid, all our right, title interest and estate of, in and to the said lot of land.

To have and to hold the same unto the said, W.T. Coleman, S.L. Coleman, Mary Thomason, Sallie Wham, and D.A. Colemen in the proportions aforesaid, their heirs and assigns forever.

And we the said legetees, devisees and Executors of the said Robert Coleman, deceased, have granted, bargained, sold and released and do hereby grant, bargain, sell and release unto the said D.A.-Coleman all our right, title, interest and estate of in and to all that tract, piece or parcel of land lying, being, and situate in the County of Greenville in the State of South Carolina, containing Fifty one and 32/100 acres, more or less, bounded by lands of John Knight on North, T.T. Andrews on East, W.T. Colemen on South and J.H. Drummond on West.

To have and to hold the same unto the said D.A. Coleman, his heirs and assigns forever. And we the said W.T. Coleman, S.L. Coleman, Mary Thomason, Sallie Whem and D.A. Coleman do each agree to pay unto our mother, the said Mary I. Coleman the sum of Five hundred dollars (\$500.00) And in the event she should from time to time or at any time need any other or further sums of money for her comfort, able support and maintenance, we will each contribute an equal amount of such sums as may be necessary for her comfortable support and maintenance.

The said sums of money including that now to be paid shall be administered by the said W.T.-Coleman and D.A. Coleman, as Trustees for our Mother and be by them kept and used for her sole, and separate use and benefit.

To the performance of this agreement we do each for us bind himself, his heirs, executors and edministrators.
