Whereas, on Dec. 30, 1921, Elizabeth W. Mayo, of the County and State aforesaid, did file her petition in bankruptcy in the United States District Court for the Western District of South Carolina, praying that she be adjudged a bankrupt; and, whereas, said Court did, upon due consideration, on the same day adjudge the said Elizabeth W. Mayo a bankrupt; and whereas, at a meeting of the creditors of the said Elizabeth W. Mayo, held on Jan. 12th 1922 J. R. Zimmerman was duly elected and qualified as Trustee of said estate and is now engaged in the performance of his duties as Trustee; and whereas, by a certain order in said case, issued on May 27, 1922 by Hon. W. H. Watkins, District Judge, confirming the report of E. M. Blythe, Esq., Referee in Bankruptcy, the said Trustee was authorized and directed to execute and deliver unto B. O. Woodward a deed conveying the land hereinafter described.
