

Whereas, heretofore, to wit: On the 14th day of Sept 1921, we sold and conveyed to Mrs. A. G. Pruitt, a certain tract of land situate in Cleveland Township, County of Greenville, State of South Carolina and particularly described in Deed recorded in Volume 76, page 12 as containing 3 5/7 acres and whereas it was our intention also to convey to said Grantee all plants, mills, machinery and fixtures and certain water rights on said tract of land, but through some omission the same was not included in said Deed and whereas we desire to correct said error, Now therefore

KNOW ALL MEN BY THESE PRESENTS, That we, Mary L. Pack and W. S. Pack,

in the State aforesaid, in consideration of the sum of Ten (\$10.00) Dollars and the Premises

to us in hand paid at and before the sealing of these presents by
Mrs. A. G. Pruitt

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Mrs. A. G. Pruitt her heirs and assigns forever:

All our rights, title and interest of in and to all plants, mills, machinery and fixtures now on the aforesaid tract of land, together with all of our rights, title and interest of, in and to the dam now across said river, with the right to maintain the same and with all water rights incident and connecting with the dam and the 3 5/7 acre conveyed by us to Mrs. A. G. Pruitt, one end of the said dam resting in land on the east side of said river;

Also all the rights which we required of, in and to the dam across the Saluda River, with the right to maintain the same and all water rights incident and connected therewith by deed of J. B. Jennings to us dated October 28th, 1921 and recorded in Vol. 71, Page 387 of said office.

It is understood that it is the intention of the Grantors to convey to Mrs. A. G. Pruitt all their rights, title and interest in land to the 3 5/7 acres shown by Plat of W. A. Heater dated July 4th 1921 and recorded in Plat Book F, page 10 and that this deed shall not affect any other lands which the Grantors may have received under their deed from Peter F. Jennings, excepting the dam and water rights in so far as they may affect the said 3 5/7 acres.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Mrs. A. G. Pruitt her

heirs and assigns, forever.

AND

We ourselves, our do hereby bind
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Mrs. A. G. Pruitt her
heirs and assigns, against
us and
heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
