on or about the 16th day of November in the year of our Lord nineteen hundred and twenty-one exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Phelma Shockley, et al

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 19th day of December 1921, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. W. S. Edwards and his heirs and assigns forever, the following described real estate: All those certain pieces, parcels or lots of land situated in Chick Springs Township, County of Greenville, and state of South Carolina and in the Town of Taylors and being known and designated as lots nos. 16 and 17 on a subdivision of lot no. 1 property of W. M. Shockley, deceased, as shown by subdivision and plat of same made by Thos. P. Linder, Nov. 1921, and recorded in the R. M. C. Office for the County and state aforesaid in Plat Book F at page 20. Lot no. 16 has a frontage of 28 feet on the north side of the National Highway and runs back in parallel lines 105 and 107 feet respectively and each has a rear line of 29 feet.

Reference is hereby craved to the plat above referred to for a more particular description of said lots.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same; and of all other persons rightfully claiming from, under, or any of them.
