on or about the 23rd day of February in the year of our Lord nineteen hundred and twenty-one exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against James Walker

demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 26th, day of March 1921 and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman

NOW, Therefore, Know all Men by these Presents, that I, E. Inman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Julia Walker, her heirs and assigns forever, the following described real estate, to-wit: "All that certain piece, parcel and tract of land situate, lying and being in Paris Mountain Township, in the County and State aforesaid, and containing Seventeen (17) acres, more or less, and having the following lines, metes and bounds, to-wit: Beginning on a stone in the White Horse Road 3xm; thence S. 84 1/2 E. 29.08 to a stone 3xm; thence N. 20 1/2 E. 27.75 to a stone 3xm; thence N. 62 W. 7.00 to a pine (now a stone) 3xm; thence N. 85 1/2 W. 20.40 to a stone 3xm on the White Horse Road; thence 6.75 down the White Horse Road to the beginning corner, and being the same parcel or tract of land conveyed to the late J.H. Walker by Marshall Thompson by deed recorded in the R.M.C. Office for Greenville County in Vol. 888, at page 403, and being known and designated as Tract #1 in the partition of the lands of J.H. Walker, deceased.
