Nevertheless, upon the following conditions however, which conditions are part of the consideration for this deed and are expressly for the benefit of all owners of lots as shown on said plat above referred to, to-wit:

- (1) No building shall be created nearer to the abutting sidewalk than twenty feet, except on lots Nos. 23 to 39 inclusive.
- (2) The facing of the lots as shown on said plat shall be strictly adhered to, however more than one lot may be used for the purpose of erecting a dwelling.
- (3) The property herein conveyed shall never be sold, remted or otherwise disposed of to negroes or persons having any percentage of negro blood.

And I do hereby bind myself as Trustee and my successors in office to warrant and forever defemi all and singular the said premises unto the said L.A. Mills, his Heirs and assigns against myself as Trustee and my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
