Prevost and his heirs and assigns the right, privilege and easement to tap or connect with the water main now being laid by said grantor down the Augusta Road in the Township and County of Greenville, in the State aforesaid; the intention of these presents being to vest in the said grantee and his heirs and assigns (and to him and them only) the right to attach to the grantor's said water main on the Augusta Road one pipe not exceeding six (6) inches in diemeter on the inside of said pipe, which pipe is to run from grantor's said

Together with the right at all times to draw water from the grantor's said water main through said six inch pipe; also, to maintain, repair and replace said pipe from time to time, as occasion may demand, and to sell to others the said water and the right to tap or connect with the grantee's said pipe at any and all times; provided that said grantee shall not sell more than two (2) taps in connection with property fronting on the west side of Club Drive, north of Riverside Drive; And the said grantor, for the consideration aforesaid, does hereby bind itself and its successors and assigns not to sell or grant to any other person, firm or corporation the right to connect the grantor's said water main with any pipe to run along Riverside Drive or to supply water to any property fronting on said Riverside Drive.

But it is fully understood and agreed that said grantor shall be under no obligation to keep its said water main in repair, nor to maintain or renew it; also that the right, privilege and easement hereby granted is to be subject to such rules, regulations and charges as may from time to time be made, fixed and established by the City Water Works Commission of the City of Greenville, and its successors and assigns;

Together with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the said M.B. Prevost and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
