A G R E E M E N T

This Agreement made and entered into this 12th day of February 1932, by and between  
The Carolina Air Transport, Inc., of the First Part, and George M. Geer, of the Second part,

W I T N E S S E T H:

For divers and valuable consideration, The Caroline Air Transport, Inc., does hereby  
covenant and agree with George M. Geer, that the said George M. Geer, commencing with February  
3rd, 1932, shall be permitted to fly any planes for pleasure flying that the Company may own,  
with the distinct understanding, however, that the said George M. Geer shall be liable for  
any and all damage done to said air planes, normal wear and tear along excepted, and that the  
said George M. Geer shall promptly pay for any and all damage done to any of said planes, and  
for all gas and oil used during his flights, and that said flights shall be limited to not  
exceeding twenty-five (25) hours flying time per year, and that this agreement shall extend  
for only two years, that is to say, from February 2nd, 1932, to February 2nd, 1934.

As part of the consideration for this agreement, the said George M. Geer covenants  
and agrees with The Carolina Air Transport, Inc., that it shall not be liable to him or any  
of his heirs, executors, administrators or assigns, or to any other person, by reason of any-  
thing whatsoever growing out of, or arising out of, the operation of said air plane or planes  
by the said George M. Geer, now shall it be liable to any person who may be riding with the  
said George M. Geer, he expressly hereby covenanting and agreeing to save harmless the said  
The Carolina Air Transport, Inc., from any and all damages, causes of action, or any thing  
whatssoever arising from or growing out of his operation of said air planes for said period  
aforesaid.

the said George M. Geer, has hereunto set his hand and seal the day and year first above  
written.
