All that certain lot of land situate, lying and being in Greenville County, and State aforesaid and having the following metes and bounds: Beginning at a stake at the intersection of Mountain Creek and Paris Mountain Road; thence N. 48-30 E. 218 ft. along said Mountain Creek to a stake; thence N. 40-15 W. 400 ft. to a stake; thence S. 48-30 W. 218 ft. to a stake on Paris Mountain Road; thence S. 40-15 E. 400 ft. along Paris Mountain Road to the beginning corner.
