the receipt whereof is hereby acknowledged, have granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Samie S. Bull
All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in the City of Greenville, on the West side of North Main Street, being known and designated as Lot No. 1 on plat of property of Frances Montgomery prepared by C. M. Furman, Jr., Engineer, April 1924, and recorded in the P. M. C. Office for Greenville County, in Plat Book 7, page 225, and being more particularly described as follows:

Beginning at an iron pin on the West side of North Main Street at point corner of lots 1 and 2, which point is 33 feet in a southerly direction from the southwest corner of the intersection of North Main and E. 14th Streets, and running thence with the point line of said lots 1 and 2 North 61-55 W. 100 feet to an iron pin on the East side of an eight foot alley; thence with said alley as a line South 19-54 East 20 feet to an iron pin on the East side of the property; thence with said Browning line South 61-55 East 100 feet to an iron pin on the West side of North Main Street; thence with said street North 19-54 E. 20 feet to the beginning point; this being one of the lots of land conveyed to me by Samie S. Bull by her deed dated April 29, A. D. 1924.

Also all my right, title and interest in and to the portion of said eight foot alley on which the above lot abuts, the same being the southern 120 feet of said eight foot alley, way as shown on the above mentioned plat; it being understood and agreed that this portion of said alley way shall be closed and shall be the property of the grantee herein who owns the property along the West side of said eight foot alley way.

As a part of the consideration for the above described lot of land, the grantee herein assumes and agrees to pay a certain note and mortgage given by Frances Montgomery to Ulysses S. Furman bearing date of April 29, 1924 and given to secure the sum of \$6,000.00, which mortgage covers the above described lot of land.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining,
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

Samie S. Bull, her heirs and assigns, forever.

AND *my self, my* do hereby bind
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

Samie S. Bull, her heirs and assigns, against

me and
heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
