KNOW ALL MEN BY THESE PRESENTS THAT We, A.D.L. Barksdale, J.A. Bull, A.P. McKissick,
Chas. E. Mackey and Arthur H. Mackey

Five DOLLARS,

to us
The City of Greenville a municipal corporation

do hereby bind
ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said
The City of Greenville, South Carolina, all that certain piece, parcel or strip of land
situated, lying and being in Ward 2 of the City of Greenville, S.C. on North Main Street
and having the following rates and bounds, to-wit:
beginning at the present corner of Main and Elford Streets and running thence with Elford
Street N. 17° 17' 11" feet to an iron pin; thence N. 17° 17' 11" 164.4 feet to an iron pipe
on line of Jane Henry Wimrine's property; thence with line of her property N. 67° 15'
feet to an iron pin in old line of Main Street; thence with the old line of Main Street
N. 17° 17' 11" to the beginning corner.
The above strip of land converted for the sole purpose of widening Main Street at this point.
It is a condition precedent that the City of Greenville shall move fences, fence posts,
shrubbery and all things necessary to be moved and leave the premises all in as good
condition as they now are with the reference especially to the sidewalks, paving and
driveways. No expense of widening or doing any of the work is to be borne by the Grantees.
If this a requirement is not carried out within one year from date of execution, the entire
agreement shall be null and void.

For value received I, Ella M. Geer, do hereby release from the within described lot of land
the lien of a certain mortgage executed to me by A.D.L. Barksdale, J.A. Bull, A.P. McKissick,
Chas. E. Mackey and Arthur H. Mackey on the 15th, day of March 1920, securing a note of
even date therefrom for \$6,000.00, said mortgage being recorded in the R.M.C. Office for
Greenville County in Vol. 91, page 266.
