Bowen, all that certain lot or parcel of land, situate, lying and being near the city of Greenville in Greenville Township, County and State aforesaid, and being sold to him and designated as lot 104 of Thacker Park subdivision of the Realty Corporation, as shown on a plat by R. C. Dalton, Engineer, March 1925, and having according to said plat the following metes and bounds, to-wit: Beginning at the corner on the eastern side of Augusta Road, joint corner of lots no. 104 & 105, thence with the joint line of said lots N. 56-08 E. 297.7 feet to an iron pin, thence N. 54-08 W. 70.3 feet to an iron pin, joint corner of lots no. 105 and 106, thence with the joint line of said lots N. 58-54 W. 75.4 feet to an iron pin on the eastern side of Augusta Road, thence with said Augusta Road S. 33-19 E. 45 feet to the point of beginning, being the same lot conveyed to me by W.
