Alvin H. Dean, his heirs and assigns, forever;  
All that certain lot of land situate on the north east  
corner of Spring and Washington Streets in the City of  
Greenville, County and State aforesaid, and having the  
following metes and bounds, to wit:  
BEGINNING at the southeast corner of said streets, and  
extending aforesaid with Washington Street, S. 71° E. 62 feet to  
the center of a brick wall; thence with the center of said  
brick wall, approximately N. 23° 34' E. 87 feet to the south east  
corner of a 12 ft. alley; thence with the Southern line of said  
alley and with the Northern or outside edge of the brick  
wall of the building on the lot herein conveyed, N. 71° W.  
63.5 feet to Spring Street; thence with Spring Street S. 20  
° 27' E. 107 feet to the beginning corner. The said lot of land  
herein conveyed being all of that certain lot of land  
conveyed to the grantors herein by J. B. Pasor by deed  
Dated March 1st, 1921 and of record in R. M. C. Office for
