(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Peoples Bank & Trust Co. all my right, title and interest, in and to those certain lots or Parcels of land situate in Greenville County, State of South Carolina, and lying on branches of Vaughus Creek, a tributary of Pacolet River, adjoining the lambs of Acker and others and bounded and described as follows, to-wit:

(1) Beginning et a stake on the edge of the old Landrum Road, which road runs up the ravine a few feet south of the present Highway to Landrum, at J.E. (2) Begin ing at a stake at a pile of stones in old chestnut stump, the southeast corner of the above described tract of land, and running thence South 74 15 West 302.5 feet to a stake; thance North 50 West 2210 feet to a stake; thence 1 35 Fast 595 feet to a stake; thence North 65 15 Fast about 302.5 feet to a stake; J.E. Morgan's now Acker's corner; thence with said Acker's line South 1 35 West 615 feet to a stake; thence with Acker's line continued South 50 East 820 feet to a stake, corner of the above described tract of land; thence South 50 Fast 1425 feet with the line of the shove described tract to the beginning, containing 16.731 acres, more or less.
