Lot No. 59 all that certain piece, parcel or lot of land, situate, lying and being; in the State and County aforesaid, about two and one-half miles North of the City of Greenville in Section known as Seven South, and being known and designated as Lot No. 59, Block "B" of Mountain View, as shown by Plat recorded in Office for Greenville County in Plat Book "A", pages 396 and 397 and having the following notes and bounds, to-wit: Beginning at an iron pin on the East side of Bailey Street, joint corner with lot No. 50, said pin being 299 feet from the corner of Green Street, and running thence North; lines of lot No. 50, S. 89-2 E. 145 feet to a pin on a ten foot alley; thence with said Alley N. 11-2 E. 50 feet to a pin, joint corners with lot No. 50; thence with lines of lot No. 50, N. 89-2 W. 145 feet to a pin on Bailey Street; thence with said Bailey Street N. 11-2 W. 50 feet to the beginning corner.

Lot No. All that certain piece, parcel or lot of land situate near the City of Greenville, County and State aforesaid, and being known as lot No. 69 of Block "B" of Mountain View as shown on Plat made by W. A. Jones, Dec. 1910, and recorded in the office of R.M.C. for County and State aforesaid in Plat Book "B", page 396-397, and having the following bounds, to-wit: Beginning at a stake on Bailey Street at the joint corners of lots Nos. 59 and 60, and running thence in a northerly direction one hundred forty-five (145) feet to a pin on a ten-foot alley; thence along said alley in a southerly direction fifty (50) feet to a pin at the joint corners of lots Nos. 59 and 61, one hundred forty-five (145) feet to a pin on Bailey Street; thence along said Bailey Street in a northerly direction fifty (50) feet to the beginning corner. This lot is conveyed subject to the same restrictions expressed in the deed of Mountain View Land Company to A.H. Pyron, recorded in Vol. 16, at page 331 in the R.M.C.
