Phillips. All that certain piece, parcel or tract of land, lying and being situate in Greenville County, State of South Carolina, and in Austin Township, containing sixty-one (61) scres, more or less, and bounded on the North by lands of Coon Watson and estate of Laura Anderson; on the East by lands of Coon Watson; on the South by lands of D.P. Cox, and on the West by lands of D.P. Cox and Estate of Laura Anderson, and being the same tract of land conveyed to the Federal Land Bank of Columbia by E. Inman, Master, by deed dated Dec. 1, 1928, and recorded in the office of R.M.C. for Greenville County in Deed Book 140, at page 102. Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold, all and singular, the said premises before mentioned unto the said parties of the second part, their heirs and assigns forever. And the said The Federal Land Bank of Columbia does hereby bind itself and its successors and assigns to warrant and forever defend all and singular the said premises unto the said parties of the second part, their heirs and assigns against itself and its successors or assigns, and all other persons whomseever lawfully claiming or to claim the same or any part thereof.
