On Perry Avenue in Ward Five (5) of the City of Greenville, and having the following 6 Meter band
to wit:

Beginning at a stake on the corner of Perry Avenue and Lawton Avenue and running thence with said Perry Avenue a distance of Ninety-two (92) feet to a stake on said Perry Avenue, thence N. 18 1/2 E. a distance of two hundred (200) feet to a stake, thence S. 72 1/2 E. a distance of Ninety-two (92) feet to a stake on Lawton Avenue, thence S. 18 1/2 W. with said Lawton Avenue a distance of two hundred (200) feet to the beginning corner of said lot being described and designated as Lot no. 1 on a plat of the Smith Homestead as made for J. The above described land is the same conveyed to me by Edith H. Lawton on the 5th day of July, 1926, deed recorded in office of Register of Meane Conveyance for Greenville County, in Book 105, Page 240. TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said Edith H. Lawton her heirs and assigns forever.
