William Burton all that parcel, tract or lot of land, being and being in Chick Springs town ship, County and State aforesaid about one hundred or more acres of the Southern side of a road leading from the residence of *W. King Kress* to a farm owned by *W. King Kress* and other, being lot no. 2 of *W. King Kress* property of *Taylor School* divided and having the following description: *Commencing on the side of road at corner of *W. King Kress* yard, thence S. 70° E. 100 feet to iron pin on *W. King Kress* property, thence S. 70° E. 100 feet to iron pin in line of road, thence S. 70° E. 100 feet to iron pin on south side of said farm road, thence with said road S. 70° E. 100 feet to beginning corner and containing about two hundred and forty acres more or less.*

The above described land is a part of the Taylor School house lot conveyed by Alfred Taylor to *William Burton* on the 17th day of May 1911, deed recorded in office of Register
