Improvement Company,

... in same full paid at and before the sealing and delivery of these presents by the grantee, hereinafter named, the receipt whereof is hereby acknowledged,
the trustee, warrant, aid and interest and of these presents that grant, bargain, sell and release unto

On the 1st inst. the Fund was opened to receive -
the first return being from a lot of land situated
being now being in the County of Salt Lake and
having been broken up into 21 lots.
The property is B. & G. Lee's which
was sold November 19, 1853 and being described
as follows: Land lot being bounded on the West
Lookout St. N. 133.

Granting of right in the property conveyed to the
Grantor herein by the Montgomery National Bank
by deed recorded in the P.M.C. Office for
Greenville County in Deed Book 72, page 167.

As a part of the consideration of the purchase
of the property, Tenant hereinafter agrees to be governed
by the following building restrictions:

1) no house to be built on said lot costing less
than \$3,500.00.
2) Property used for White residence purposes
only; not to apply to servants' houses.

(3) W. lot owners to be subject to Sanitary rules
and regulations passed by a majority of Property
owners in this subdivision;

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and..... his
heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and hus.
and against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
