to me in hand paid  
at and before the sealing of the presents by O. M. Howard.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

O. M. Howard his heirs and assigns, all that  
real estate or lot of land in Greenville County  
County, State of South Carolina, lying  
and being partly within said city, partly without the  
corporate limits of the city of Greenville, County  
and State aforesaid, on the northeast side of Augusta  
Street, and being known and designated as lot no.  
6, in the plan and survey property as shown on  
plat recorded in the C. I. S. Office for Greenville  
County, in Plan Book C, page 186, and having according  
to said plat the following metes and bounds, to-wit:  
Beginning at an iron pin on the North side of  
Augusta Street, joint corner of lots nos. 6 and 7;  
thence, with joint line  
is said lot N. 47-0-7 E. 257.6 feet to an iron  
pin on an alley, N. 78-24 W. 81.1 feet thence  
still with alley E. 71-40-27.80 feet to an iron  
pin corner of lot no. 8; thence with line of that  
lot E. 47-0-7 W. 180.2 feet to an iron pin on  
Augusta Street; thence with Augusta Street E.  
47-0-3 E. 60 feet to the beginning corner.  
The Grantee herein assumed a \$6000.00 mortgage  
executed by J. M. Harris with interest from this  
date.

- Subject however to the following restrictions, which  
are part of the consideration for this deed and  
are made for the benefit and protection of the  
other lots shown on the plat above referred to,  
which restrictions shall remain effective for  
a period of (20) years from the date of this  
deed, to-wit: (20) years from the date of this  
(1) the property herein conveyed nor any part thereof  
shall not be sold, or otherwise disposed of to  
anyone.  
(2) The said property shall not be used for any  
unlawful business nor for anything which  
would constitute a nuisance.  
(3) The property herein conveyed shall not be re-let  
nor subdivided so as to face any other direction  
than as shown on said plat.  
(4) No building shall be erected upon said property  
within thirty-five (35) feet of the present line off  
Augusta Street.  
(5) No building costing less than four thousand  
(\$4,000.00) dollars shall be erected upon said  
lot other than out-buildings appurtenant to a  
dwelling.

do hereby bind

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
