All my one half undivided interest, and to, all part, parcel, or lots, of land being in Bates Township, Town of Marietta, and State and County aforesaid: More particularly described as follows;

(a) Beginning at a point on Cleveland Avenue 174.5 feet North from the point corner of J. Norwood Cleveland and R. Mays Cleveland property, with the lot of H. A. Bates (H. A. Bates lot being just North of the Nannie Bates property) running 20 feet N. 22-20 E. along Cleveland Avenue to a stake; thence 435.6 feet S. 67-40 E. to a stake; thence 30 feet S. 22-20 E. to a stake; thence 435.6 feet N. 67-40 W. to the Beginning; Lot #4 on plat of Marietta Tract, surveyed 1927 by Dalton.

(b) Beginning at southeast corner of lot #1 running thence 380 feet N. 22-20 E. to a stake; thence 137.6 feet S. 67-40 E. to a stake; thence 380 feet S. 22-20 E. to a stake; thence 137.6 feet N. 67-40 W. to the Beginning; Lot #4 on plat above referred to.

(c) Beginning at the Northwest corner of lot #1, running thence 100 feet S. 22-20 E. to a stake; thence 435.6 feet N. 67-40 W. to a stake on Cleveland Avenue; thence 100 feet up Cleveland Avenue N. 22-20 E. to a stake; thence 435.6 feet S. 67-40 E. to the Beginning; Lot #3 of plat above referred to.
