 All that certain parcel of land
 situated, lying and being in Greenville County, and State aforesaid, just beyond the
 limits of the City of Greenville, and known
 and designated by lot No. 20 of Amherst Place,
 according to a plat made by T. C. Hart
 May 1, 1828, recorded in the Office of the Clerk of the County Court Book of Plat Maps
 page 125, and having the following metes
 and bounds:
 Beginning at stake on Augusta Place Street
 at corner of lot No. 19, and running north
 westly of lot No. 19, 17 ft. 6 in. 3 ft. 1 in. 18 ft. 2 in. to stake
 at corner of lot No. 19, thence N. 10° 50' E. 60 feet
 to stake, corner of lot No. 21, thence along line
 of lot No. 24, 17 ft. 6 in. 3 ft. to stake on
 Augusta Place Street, thence along line
 of said street S. 10° 30' E. 60 feet to the be-
 ginning corner, being the same lot as last
 described, to J. C. Dunham and the grantor
 herein, by J. C. Dunham, the witness of the said
