I, E. Inman Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Frank L. Moon

on or about the 14th day of January in the year of our Lord nineteen hundred and Twenty seven exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against Marion L. Moon, Maxwell Moon, Robert R. Moon, Edward P. Moon and Brown Moon.

Remainder taken as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 12th day of February 1927, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman Master in and for the County aforesaid, to Frank L. Moon for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. _____)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Frank L. Moon,

his heirs and assigns forever, the following described real estate:

"All that certain Piece, parcel and tract of land situated lying and running from Township, Greenville County, State of South Carolina, and being a Part of the 17th acre tract of the J. P. Moon estate and containing 3¹/₂ acres and having the following corners and bounds and courses and distances, as shown by a survey and Plat of same made by W. J. Riddle, Surveyor, to-wit: Beginning at a Point on the road leading from the Augusta Road to Reedy Fork Church, and running thence with the said road N. 76-30 W. 663' to a stake on said road; thence N. 15-52 E. 233' across a public road to a stake; thence S. 70 E. 662' to a stone; thence S. 15-15 W. 223' to the beginning corner."

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining, and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same, and of all other persons right-fully claiming from, under, or any of them.
