M. C. Office for Greenville County, in Plat Book 18, at page 210, and having the following limits and bounds to wit: Beginning at a point on the West side of Ridgeland Avenue, at corner of lots Nos. 28 and 29, and running thence along Ridgeland Avenue, S. 12.137. 86 feet to corner of Lot No. 30, thence with line of Lot No. 30, S. 16.2 feet to point on land of Cleveland Park, thence with land of Cleveland Park, N. 1.39. 82 feet to corner of Lot No. 28, thence with line of Lot No. 28, S. 79. 40. 168. 5 feet to point on Ridgeland Avenue, the point of beginning.

Said dwelling must face the street. (2) No building shall be erected nearer the curb than 4 1/2 feet. (3) The property hereby conveyed shall never be sold, rented or otherwise disposed of to any person other than the said J. C. Jones, his heirs and assigns, and the property hereby conveyed shall be used for residential purposes only.
