(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Mary A. Cochran, all my right, title and interest aforesaid being a one-half interest in & to all that piece, parcel, and lot of land situate, lying and being in the County and State aforesaid, on the Northeast corner of the Augusta Road, near the City of Greenville, South Carolina, in a triangular shape adjoining the present residence of the grantee above named, and having the following metes and bounds, corner and plats as follows: Beginning at a stake on the Northeast corner of the Augusta Road, at the southern corner of lot No 3, now owned by the grantee, and running along said road 8.53-21 feet, thence four further feet to a stake, thence in a northeasterly direction eighty seven and four-tenths feet to a stake on the line of the said grantee, which stake is ninety-one and five-tenths feet northeasterly from said road; thence along the line of the said grantee 59 ft. ninety-one and five-tenths feet to the beginning corner. This triangle being cut off from the northeast corner, lot No 3, on plat of the property of J. F. Cochran and W. G. Case, which plat is recorded in the R.M.C. office in said County in Plat Book F page 262.

Also, all that piece parcel or tract of land lying, situated and being in Greenville Township, Greenville County, State of South Carolina, and being known and designated as lot No. 3 of the Augusta Road property, by J. F. Cochran and E. G. Case according to a plat made by R. E. Dalton, Engr., September 1934, having the following metes and bounds as aforesaid: Beginning at an iron fence post at the Southern corner of Augusta Road and Augusta Place Street, and running thence N 58-53-0 E. 268.3 feet to an iron fence corner of lot No. 4, thence with the line of lot No. 4 S 31-30-8 82.15 feet to corner of lot No. 2; thence along line of lot No. 2 S 59-0 E. 732.8 feet to an iron fence on Augusta Road, thence along Augusta Road S 55-33-21 E. 87.6 feet to the point of beginning.
