land situated, lying and being in the County
and State aforesaid, just outside the corpor-
ate limits of the City of Greenville, and
being a portion of lot no 7 of Block A, as
shown on plat of Marion Circle lands, re-
corded in Plat Book A, at page 141 and hav-
ing the following written and bounded, to wit:
beginning at a stake on the west side
of St. Clare St 136 feet from the intersection
of St. Clare St and the extension of Hampton
Avenue, and running thence with said St.
Clare St N. 12° E. 62 feet to corner of lot no 6;
thence with line of lot no 6 N. 7½ W. 114 1/2
feet to an iron rail corner of lot of Henry
Greene, being in a line parallel with
