NOW, therefore, Know all Men by these Presents, That I, *E. J. Jansen*, Master in and for the County of Greenville, aforesaid, in consideration of the sum of *One Hundred (100.00)* Dollars,

to me paid by the said *The Carolina Loan and Trust Company, a Corporation*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said *The Carolina Loan and Trust Company, a Corporation, the following described real estate:*

"All three three tracts of land situate in third city of the City of Greenville, County and State aforesaid, on the Southeast corner of Rose Avenue, and Hamilton Street, and having the following Metes and Bounds: Beginning at an iron pin on the Southeast corner of Rose Ave. and Hamilton Street and thence running along the South side of Rose Ave. N. 17 E. 200.5 feet to an iron pin at the beginning corner of Lot No. 17; thence along the line of that lot S. 20.2 feet to the front corner of lots Nos. 6, 7, 17 and 18; thence along the lines of lots Nos. 6, 5 and 3, S. 77 W. 208.9 feet to an iron pin on the East side of Hamilton Street; thence along Hamilton Street, on the South side, N. 2 E. 120.2 feet to the beginning corner being designated as Lot Nos. 1, 2, and 18 of Block H, of the Chargin Springs Land Company Property, as shown on a plat of this land recorded in Vol. 6, Page 41, R.
