Now, in consideration of the sum of One (\$1.00) Dollar and other valuable consideration, to me in hand paid, I, Lee Batson, do hereby consent to the operation and maintenance of said sewerage system and any replacements thereof and to the emptying into said Reedy River by Brandon Corporation, its successors or assigns, of sewerage, dyes, chemicals, water and refuse, and do hereby release said Corporation, its successors and assigns, from any damages which may have resulted, or which may hereafter result, therefrom to that certain tract of land described in the deed from T. L. Batson to Lee Batson, dated December 8th, 1909, and recorded in the R. M. C. Office for Greenville County in Deeds Volume 5 at page 702.
