(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Peoples National Bank, as Executor of Estate of W. D. Davenport, deceased, all that piece, parcel or tract of land situate near Rock Shoals, in the County of Greenville, State of South Carolina, known and designated as Tract #3 of the lands of Katrine Manufacturing Company as shown on the plat made by S. G. Rogers, December, 1816, and having the following lines and bounds, to wit: Beginning on the West bank of Reedy River, at Austin's Corner and running thence with Austin's line S. 16° 12' 00 chains to stake in the center of the New Mill Road, Austin's Corner; thence with center of said Road S. 45° 46' 7 Chains; thence still with center of said Road S. 29° 3' 50 chains; thence still with the center of said Road S. 22° 3' 6. 16. 72 chains to stake, at bend in Road; thence N. 66° 2' 9. 30 chains to oak; thence N. 58° 6' 7. 48 chains to stake; thence S. 50° 6' 1. 02 chains to stake on the West bank of Reedy River; thence up West Bank of Reedy River in a Northern direction 31. 80 to the beginning corner containing 26. 62 1/2 acres, more or less.

Also, all that certain tract of land situate in the County and State aforesaid and adjoining the tract above described and being taken from the Northern end of Tract #4, as shown on said plat being more particularly described as follows: Beginning at the junction of the New Mill Road with the Old Mill Road, former tract above described and running thence with the center of the Old Mill Road in a Northern direction 10 chains to pine, Austin's Corner; thence with said Austin's line N. 62° 6. 60 chains to stake in the center of the New Mill Road, corner of tract last above described, thence with the center of the New Mill Road S. 40° 2' 6. 7 chains to the beginning corner.
