all that piece, parcel and tract of land lying, situate and being in Bates Township, State and County aforesaid known as the land conveyed to John Lynch by deed from W. H. McEowan, in 1916, and recorded in the P. M. C. Office Greenville County in Book 7, Page 312. Adjoining lands of C. H. Duck, W. M. Watson and others.

O. 7.0 m, thence S. 60 W. 6.00 to a stone on a road, thence with road S. 1 E. to a stone, thence N. 22 W. 5.87 to a chestnut stump, thence S. 84 E. 2.16 to an angle in road, thence N. 77 E. 7.77 to an angle in road, thence S 77 E. 3.30 to the beginning corner and contains nine (9) acres, more or less.
