Roy H. Bozeman, as Receiver for the Bank of Commerce, Greenville, S.C.

All that certain lot of land, situate, lying and being known and designated in Lot no. 11, Block "G" as shown on plat recorded in the office of the R. M. C. for Greenville County in Plat Book "F" at page 171.

Beginning at a point on West Mills Avenue, joint corner lots nos 9 and 11, running thence with said Avenue S. 45-27 N. 60 feet to lot no. 13; thence with line of lot no. 13 N. 44-33 W. 180 feet; thence N. 45-27 E. 60 feet to lot no. 9; thence with line of lot no. 9, S. 44-33 E. 180 feet to point on West Mills Avenue of beginning.
