WHEREAS, *Chas. M. Britton, Asheville, N.C. and J. H. Britt and S. J. McStimney, Greenville, S.C.*

did on the *5<sup>th</sup>* day of *July*, 193*2*, file with the Secretary of State a written Declaration signed by themselves, setting forth:

- FIRST: That their names and residences are as above given.
- SECOND: That the name of the proposed Corporation is *Britt McStimney Company, Inc.*
- THIRD: That the principal place of business is *Greenville, S.C.*
- FOURTH: That the general nature of the business which it is proposed to do is

*A general brokerage business with power to carry on any other lawful business whatsoever in connection with the foregoing, which is to be done directly or indirectly to promote the interests of the Corporation, of the estate the value of the properties and to open and exercise all rights, powers, and privileges which are now, or may hereafter be conferred under the laws of South Carolina upon the Corporation.*

FIFTH: That the amount of the capital stock is *Five thousand* Dollars, payable *in cash*

SIXTH: That the number of shares into which the capital stock is divided is *two hundred* of the par value of *fifty*

SEVENTH: That, after the notice, a meeting of the subscribers was held on the *20<sup>th</sup>* day of *June*, 193*2*, at which a majority of all stock in value being present in person or by proxy the following were elected directors:  
*J. H. Britt, S. J. McStimney and Chas. M. Britton*

EIGHTH: That subsequently there was elected as President *J. H. Britt* as Vice-President, *S. J. McStimney*; as Secretary, *Chas. M. Britton* as Treasurer, *J. H. Britt*

NINTH: That all requirements of Chapter *153* Article *2* of the Civil Code of South Carolina, 1922, 1932 and all amendments thereto, have been duly and fully complied with 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in *The Greenville News* a newspaper published in the County of *Greenville*

NOW, THEREFORE, I, *W.P. Blackwell*, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
