Know all men by these Presents: That I, August Schwiers of said County and State for and in consideration of the terms, conditions and privileges hereinafter expressed and for the sum of One Bollar (\$1.00) to me in hand paid by Greater Greenville Sewer District Commission of Greenville, S. C. the receipt whereof is hereby acknowledged, do hereby grant unto the said Greater Greenville Sewer District Commission, its successors and assigns, the right, privilege and easement to go in and upon that tract or lot of land situate in Greenville Township, in said County and State, Beginning at a point of land situate in Greenville Sewer District's outfall, same being near edge of Schwiers in 36" line of Greater Greenville Sewer District's outfall, same being near edge of Schwiers in northwesterly direction across my property a distance of 2030 feet more or Road, thence in northwesterly direction across my property a distance of 2030 feet more or less to the line between my land and the land of Henry Schwiers.

and to construct, maintain in and upon and use in and through said premises, in a proper manner, with necessary apparatus and appliances such as machinery, air vents, manholes, blowoff connections and any and every necessary and proper attachment, pipe lines for sewerage purposes through the premises above described, together with the right at all times to enter in and upon said premises for the purpose of inspecting and making necessary repair and alterations thereon of said lines, together with the right to cut away and keep clear of said pine lines all trees and other abstructions that may in any way endanger the proper operations of same.

It is understood and agreed that the easement herein granted shall extend throughout the property of the grantor about 2030 feet, and shall be of such width as the grantee shall deem necessary for the purposes herein specified, and that the damage for which Greater Greenville Sewer District Commission may be held liable shall be confined to that arising from the use of this strip only, and nothing beyond.

It is further agreed and understood that this easement is to be used only during the construction or repair of said pipe line and with the exception of the right of Greater Greenville Sewer District, its successors and assigns, agents, servants and employees to inspect said pipe line and to enter at any point and make repairs, the owner has the same right as he now has to cultivate and use the land.

It is fully understood that all pipes will be laid at sufficient depth below the present suface of the ground to all unobstructed cultivation, except at manholdes, branches plainly defined diames or gullies.

It to foreign agreed and as a part of this consideration herein that the grantor herein, his heirs and assigns, may make taps or connection with said pipe lines, at his own expense, to serve not more than the same number of dwellings now on the premises, provided, however, that such connections or taps be made only under the rules and supervision of the engineers representing Greater Greenville Sewer District Commission or their successors.

It is futher understood and agreed that in case of future damage to crops or property due from accident in said pipe lines that Greater Greenville Sewer District Commission shall pay reasonable damage therefor.

The payment and privileges above specified are nereby accepted in full settlement of all claims and damages for said easement.
