"Special Provisions:"

It is agreed and understood that there is to be an entrance to W. H. League's property running through Walter Goldsmith's property. The said entrance to begin at a point near where the proposed new road runs into the present road, running on a even grade back to the line between Goldsmith's and League's about 65 feet north of the Lonesome Pine, intersecting with a terrace on the said League's land. The right-of-way for this special driveway is to be of a permanent nature so that W. H. League and his heirs and assigns can use same for driving purposes when they see fit.

It is understood that the timber cut on the property belonging to W. H. League is to remain in his possession after being cut and the said timber shall be trimmed up and laid along the road at convenient places accessible to Mr. League or his Agents.

There is to be an entrance to Mr. League's property just where the new proposed route begins and the said County is to make this entrance free of cost to W. H. League.

The above conditions are essential and a full compliance with them are requested before the right of way furnished by W. H. League is binding.

Together with all and singular, the rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident or appertaining. It is agreed that buildings, fences, signs, or other obstructions will not be erected by me (or us) my heirs assigns, or administrators within the limits of the right-of-way herein conveyed and that such buildings and fences as are now within the limits of the right-of-way herein conveyed will be moved from the right-of-way and restored in as good condition as before moving at the expense of the Supervisor of Greenville County, State of South Carolina.

To Have and to Hold, all and singular, the said right-of-way and the rights hereinbefore granted, unto the said Supervisor of Greenville County, South Carolina, its successors and assigns forever.
