

All that certain piece, parcel or tract of land situate lying and being in Austin Township, Greenville County, State of South Carolina, in the Town of Mauldin S. C., lying on both sides of the paved highway leading from Greenville S. C. to Laurens, S. C., and containing 5 acres, more or less, being the lands on which a two story brick store building is erected, and on which is located the home of the said John S. Still Jr., which property has a frontage of 600 feet, more or less, on the said Laurens Road and runs back to the right of way of C. & W. C. Railway and being the same lands conveyed to John S. This portion was conveyed to Mrs. R. A. Whalley by John S. Still by deed dated March 6, 1931, and recorded in the R. M. C. Office for Greenville County in Vol 156, page 91, and released by C. F. Myche from the lien of his mortgage, recorded in Mortgage Book 215, page 165.

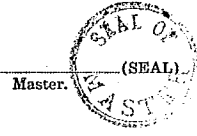
