In consideration of the sum of Eight Hundred Fifty (\$850.00) Dollars,to me paid by Miles Florence McFerney,in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Miles Florence McFerney,

Hereinafter and successively forever, the following described real estate,

All that certain tract or lot of land in Greenville Town ship, Greenville County, State of South Carolina, near the Easley Bridge Road, known as a portion of lot no 22 in Block D, and part of the property of Julia D. Hartline, recorded in the office of R. M. Co. General Register in Plat Book E, at page 20, and containing the following acres and dimensions according to said plat:

Begins at a tree pine in the Gordon Street 100 feet East of the Southwest corner of Washington Avenue and Gordon Street, and running thence with Gordon Street N.E. 100 feet to a tree pine, corner of lot no 23; thence with line of said lot S. 22-10 E. 50 feet to a tree pine, thence S. 77-24 100 feet to a tree pine, thence N. 22-10 E. 50 feet to the beginning and so forth.
