Beginning at a pin on the west side of Rowley Street one hundred fifty (150) feet from Park Ave., running thence W. 20-19 E. fifty (50) feet with Rowley Street to an iron pin; thence N. 77 W. one hundred (100) feet, more or less, to an iron pin on the E. N. Middle lot; thence S. 20-19 W. fifty (50) feet to an iron pin on driveway between lots of India P. Asbury (now deceased) and W. W. Goldsmith; thence with said driveway S. 77 W. one hundred (100) feet, more or less, to the beginning.
