release unto the said John L. G. Greenville Inc., a corporation of South Carolina,

all that given, paid or due of him in Greenville,

containing of acres more or less, bounded by lands of
 J. H. Hobbs on the north; lands of J. H. Hobbs and R. Riddle on
 the East, lands of James Hickam and E. B. Hendry on the South,
 and lands of W. A. Davis and Tom McRae on the West, all of
 which is fully set out upon plat of same by J. P. Riddle,
 Surveyor, dated June 24th, 1922, copy of which plat is on
 file with the Federal Land Bank of Columbia, and being
 the same tract conveyed to John L. Davis and Thomas J.
 Davis by Henry McRae by deed dated July 14th, 1903, and
 half interest in which was conveyed to John L. Davis by
 Thomas J. Davis by deed dated Jan 12, 1914.

 heirs and assigns, against all and every person, party and party whomsoever lawfully claiming, or shall claim, the same, in any part thereof.
