in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. S. Meekins, his heirs and assigns all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina.

All that certain piece, parcel or tract of land lying being and situate in the County and State aforesaid and in Dunklin Township with the following metes and bounds, to wit: Beginning at a big red oak and running thence S. 54 W. 1/2 c. to me or mine in thence S. 41 E. 27.90 to me or mine on Co. B. line, thence N. 72 E. 4.95 to corner of Chapman lands, thence N. 34 W. 29.90 to the beginning corner, and containing 26.38 acres, more or less, and being the first recorded tract of land in a deed to me executed by South Carolina State Bank as Receiver for the Peoples Bank of Mountain View, said deed being recorded in the R. M. Office for Greenville County in Book 172 at page 57. Bounded by lands of the said W. S. Meekins on the north, on the east by lands of Pauline Chapman, the said W. S. Meekins on the south by the Co. B. line, and on the west by lands of me or mine.
