containing 55 acres, more or less, and having the following metes and bounds: Beginning at a Hickory tree, running thence S. 41 1/2 E. 15.30 to stone 3x; thence N. 48 E. 3.84 to stone 3x; thence S. 16 1/2 E. 0.31 to stake 3x nm; thence N. 75 1/2 E. 13.16 to a stone 3x nm; thence due North 5.22 to stake 3x nm; thence N. 24 W. 5.40 to stake 3x near Palzer Road; thence N. 1 1/2 E. 6.80 to poplar 3x nm on branch; thence N. 81 1/2 W. 2.00 to stake; thence N. 53 1/2 W. 18.00 to corner in branch; thence S. 48 W. 18.50 to beginning corner; the tract above described containing 55 acres.
