(The receipt whereof is hereby acknowledged), have Granted, bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Luther Mcbee and his heirs and assigns  
all that certain piece, parcel or lot of land  
situate, lying and being on the south side of Stone Ave.  
in Ward 1 of the City of Greenville, County and State  
aforesaid street having the following lines and boundaries  
beginning at a stake on Stone Ave. at corner of said  
lot now or formerly owned by myself and W. A. Hale  
Trustee and running thence S. 4° 4' 162 ft. along  
western boundary of the Ellas G. Mcbee lot to a  
stake, thence N. 34° 24' 10 ft. to a stake; thence N. 44°  
E. 162 ft. to a stake on Stone Ave; thence S. 84° 6. 10 ft.  
along Stone Ave. to the beginning corner and being  
the corner lot of land so released to me by W. A.  
Hale, Trustee, on Aug. 23, 1928 by a deed recorded in  
the Office of R. M. C. for Greenville County in Book 127  
at page 164.

Also all that other certain lots or parcels of  
land adjoining the above described parcel and boun-  
dary at a stake on the south side of West Stone  
Ave. at the corner of land conveyed by W. A. Hale  
to Mrs. Delia Mary White and running thence along  
said Stone Ave. N. 84° 24' 66 ft. to a stake, thence  
S. 84° 6. 162 ft. to a stake, thence S. 84° 6. 162 ft. to a  
stake on the southwest corner of Mrs. White's lot,  
thence along the line of said lot N. 4° 8. 162 ft. to  
the beginning corner. This being the same lot of  
land conveyed to me by W. A. Hale by his deed  
dated August 23, 1920 and recorded at the office  
for R. M. C. for Greenville County in Book 68 at page  
1234. Reference is made to the record of that deed  
for the history of various conveyances effecting  
this lot. The two lots here described constitute a  
single parcel with a frontage of 76 ft. on Stone  
Ave. and running back in parallel lines 162  
ft., but there has been conveyed away a 10 ft.  
strip from the last described lot by a deed  
recorded in Book 137 at page 164, and the lot now  
contains 66 ft. by 162 ft.
