

State of Carolina Release of Judgment
County of Greenville
Whereas, heretofore, to wit, February 2, 1930, W. S. Conyers and Marie G. Conyers made and executed to Eddie H. Blakemore their promissory note secured by a mortgage covering two tracts of land on Scuffletown Road, Greenville County, containing respectively 48 2/3 acres, more or less, and 70 3/4 acres, more or less, and

Whereas, subsequently, the above-referred note and mortgage were assigned to J. H. Morwood, who is now the owner and holder of same, and W. S. Conyers and Marie G. Conyers desire to convey said property to J. H. Morwood in satisfaction of said mortgage debt, and

Whereas, the undersigned is willing to release said property from the lien of the judgments herein-after referred to, and do declare that the conveyance may be made to J. H. Morwood as aforesaid;

Now, therefore, the undersigned, for value received, doth hereby release and forever discharge the property on Scuffletown Road, consisting of 70 3/4 acres, more or less, conveyed to W. S. Conyers December 14, 1910, by deed recorded Vol. 9, page 237, W. M. C. Office and 48 2/3 acres, more or less, hereto before mentioned to W. S. Conyers, December 9, 1910, by deed recorded Vol. 9, page 358, R. W. C. Office, Greenville County, from the lien of three certain judgments dated January 28, 1935, and recorded in the office of the Clerk of Court of Greenville County, in Judgment Roll E-4732 and Judgment Roll E-4733, and that certain judgment doth date August 20, 1935, and recorded in the office of the Clerk of Court, Greenville County, in Judgment Roll E-5151.
