 Whereas, the above named February 2, 1930, W. P. Conyers and Marie G. Conyers made and executed to Dallis W. Blakemore their promissory note secured by a mortgage covering two tracts of land on Scuffle-town Road, Greenville County, containing respectively 48 2/3 acres, more or less, and 70 3/4 acres, more or less, and
 Whereas, subsequently, for value received said note and mortgage were assigned to J. W. Norwood, who is now the purchaser and holder of same, and W. P. Conyers and Marie G. Conyers desire to convey said property to J. W. Norwood in satisfaction of said mortgage debt, and
 Whereas, the undersigned is willing to release said property from the lien of the judgments herein after referred to but only in case that the conveyance may be made to J. W. Norwood as a-fore said;

Office, Greenville County from the lien of those certain judgments dated January 28, 1935, and recorded in the office of the clerk of Court of Greenville County, in Judgment Roll E. 4732 and judgment Roll E. 4733, and that certain judgment dated August 20, 1935, and recorded in the office of the clerk of Court, Greenville County, in Judgment Roll E. 5151.
