"All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in Greenville Township, on the north side of Franklin Road, and being known and designated as Lot No. 14 on Plat of the property of E. S. Gear, as recorded in the R. M. C. Office for Greenville County in Plat Book "H", page 142, and having according to said plat the following mates and bounds, to-wit:

"Beginning at an iron pin on Franklin Road at the corner of lot now or formerly belonging to Annie T.
