This indenture of lease, made and concluded at Greenville, South Carolina, this the 19th day of January A. Curdts and Robert Wilson, hereinafter called the lesses, parties of the second part,

MITNESSETH:-

That the said lessor has granted and leased unto the said lessees the entire Liberty Building situate on the west side of South Spring Street in the City of Greenville, State and county aforesaid, together with all furniture, furnishings and equipment now in said Emilding and belonging to the lossor.

To have and to hold unto the said Lesseen, their heirs, executors, administrators and assigns for the full term of one year, cornencing on January 10th, 1933, and ending om the 2th day of January, 1934, receiving therefor a rental of \$3,000, payable \$350 monthly, in advance; it being distinctly understood that this rental shall not commence to accrue until the date when the Lasser gives to the lessess possession of that portion of the Liberty Bullding watch is now being used in the operation of a motion gioture business under the mane of the Licerty Theater.

It. Is suitually understood and agreed by and between the parties hereto that the lessees are hereby granted the refusal of a lease on the same premises for an additional peried of from one to four years after the expiration of the within lease, at a rental to later to agreed upon by the lassor and the lassees.

It is distinctly understood and agreed by and between the Lessor and the Lessoes that all regains and alterations which are made to the Building during the term of this lease are to be made at the expense of the lesses and that no alterations shall be made without the written consent of the lessor.

It is further understood and egraed that the cost of coal, water, janitor service and other expenses connected with the operation of the Building shall be taken care of by the tesses.

And the suff Lesses, for and in consideration of the above letten premises do hereby bind themselves, their heirs, executors, administrators and assigns to pay to the Spartan healty Company, its successors and assigns, the above stipulated rent in the manner herein cooperad.

And it is further stipulated and agreed by the parties to these presents that if the Lessees shall, at any time, to thirty days in arrears with payment of the rent to the Lessor, then the unpaid belance of the \$3,000 rental shall become due and payable immediately and the lesser shall have the right to annul and terminate this lease, eject the tenants from the provises and institute legal proceedings for collection of the unpaid rent.

It is mutually auderstood and agreed that destruction of the premises by fire or any other casualty shall terminate this agreement, at the option of the Lessor.
