Gorman, Bankrupt, in the State aforesaid, in consideration of the sum of Two Thousand & no/100 (\$2000.00) Dollars, to me in hand paid at and before the sealing of these presents by M. H. Gorman (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. H. Gorman, his heirs and assigns, all that certain piece, parcel or lot of land, situated, lying and being on M^c-Donald Street in the City of Greenville, S. C. in the "North Hills" subdivision and known and designated as Lot Number Twenty-Five "A", (25-A) in plat recorded in R. M. C. office for said Greenville County in Plat Book "H" at Page 90, and having according to said plat the following metes and bounds, to-wit:
