in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said R. H. Bridgeman and H. R. Stephenson

All those certain tracts of land in Greenville County, South Carolina, described as follows in deed of E. Suman, Master, to Citizens Bank of Taylors, dated June 11, 1927, and recorded in Deed Book 140, page 1, R. M. O. office for Greenville County:

(A) All that certain piece, parcel or tract of land situate, lying and being in the County and State aforesaid, bounded by land of Stanley Jones, Emanuel Morris and others, and containing 54 acres, more or less; and also one other, small tract of land in said County and State on the Ridge Road to Pelham, containing $1\frac{1}{8}$ acres, more or less, and both of said tracts having the following meter and bounds, to wit: Beginning at a stake on the Ridge Road to Pelham Mills, and run thence S. 16 E. with line of land of Charlie Morris, 25.35 to a stake; thence S. 87 E. 25.75 with line of W. R. Hudson to S. Kurn; thence N. 17 $\frac{1}{2}$ W. 11.20 to a stone; thence S. 75 W. 3.60 to a maple stump and stone; thence N. 17 W. 12.78 to a stone; thence N. 13 $\frac{1}{2}$ E. 5.20 to a stone on the said Ridge Road; thence S. 55 W. 7.00 with said road to a stone; thence N. 76 $\frac{2}{3}$ W. 2.94 to an iron pin; thence N. 78 $\frac{1}{2}$ W. 7.85 to an iron pin; thence N. 83 $\frac{1}{2}$ W. 7.09 to the beginning corner; and being the tracts of land conveyed to Charlie Morris by E. O. Bighash by deed dated January 1st, 1907, recorded in Vol. 153, page 381.

(B) All that certain tract, piece or parcel of land lying and being situated in Butler Township, in the State and County aforesaid, containing 22 $\frac{1}{2}$ acres, more or less, and bounded by lands of P. H. Jones, R. L. Smith, S. L. Vaughn and others; this being a part of the 58 acres formerly conveyed to J. F. Freeman and B. F. Morgan by E. Suman, Master for Greenville County, the other 35 $\frac{1}{2}$ acres being sold to P. H. Jones, M. E. Hudson and Julius Morgan by deed bearing date of January 2, 1920.

This deed is made by me in pursuance of the authority vested in me by an order of the Court of Common Pleas for Greenville County, South Carolina, in the case of Exp. Parte Albert S. Faint, as State Bank Examiner, in the Citizens Bank of Taylors S.C. which order is dated December 19, 1932 and another order of the same Court in the same case confirming this sale dated February 8, 1933.
