all that certain lot of land situate in Black Springs Township, Greenville County, S.C. known and designated as lot #7 of the subdivision known as Piedmont Park according to a plat of the same recorded in the R.M.C. office for Greenville County, S.C. in Plat Book '7' page 270 and being the same lot of land conveyed to me by Mrs. Annie H. Sumner.

The said lot, according to the Plat mentioned above, has the following notes and bounds:

Beginning at an iron pin on Maple Drive, corner of lot no 8, and running thence with line of lot no 8 N. 53-25 W. 224.69 feet to pin; thence S. 6-42 W. 120 feet to an iron pin, corner of lot no 6; thence with line of lot no 6 S. 83-25 E. 224.87 feet to pin on Maple Drive; thence with said Maple Drive N. 6-35 E. 120 feet to the beginning corner.


